## Rules and Requirements for the purchase of and Maintaining a Parking Hanger at Apopka Christian Academy

1. In order to purchase a non refundable hanger for the current school year, the student must be a sophomore, junior or a senior currently registered at Apopka Christian Academy, the student must hold a valid drivers license.
2. Students are only allowed to park in the designated student parking lot. **No Exceptions.** Students parking in an unauthorized area, or who do not move their vehicle at the time designated will forfeit hanger and are subject to towing.
3. Students must follow the flow of traffic at all times.
4. Students are not permitted to transport or have any other student in his/her vehicle without parental consent of the other student both confirmed and approved by ACA office/administration prior to transport.
5. The hangers are non-transferable, and therefore, the student is not allowed to give, to loan, or sell his/her parking hanger to another student. **Doing so will result in forfeiture of the hanger.** In such cases, the student will be responsible for purchasing another hanger at the cost of \$25.
6. Students must leave their cars immediately upon parking them on campus. No sitting or congregating in or near vehicle allowed.
7. The administration has the right to suspend or revoke a parking permit for violation of school policy, including unexcused and/or excessive absences, tardies, or early departures.
  - a. If a student is late to school five times during a nine week marking period.
  - b. If a student is considered truant in accordance with ACA handbook and state law.
  - c. Students must drive safely when entering and exiting the campus.

I \_\_\_\_\_ as a prerequisite to the issuance of an Apopka Christian Academy parking permit, I understand and have read the parking regulations and consent to all policies concerning the restrictions, conduct of person, search of vehicles with due cause, and safe, courteous operation of the vehicle while on campus. I also understand that failure to abide by the terms of this agreement will result in disciplinary action and/or revocation of the parking permit for an indefinite period of time after review by the administrator in charge. I further understand that this shall serve notice that Apopka Christian Academy, Victory Church World Outreach, and First Baptist Church of Apopka are not liable for any vandalism to, or theft of or from, vehicles parked on this property.
